

Fulton Armory McKee Memorial Match (previously M14 Heritage Match) Raffle Terms and Conditions

1. Eligibility

1.1. The raffle, for the Fulton Armory M14 and additional prizes, is open to all participants who sign up for, attend, check in for, and participate in the McKee Memorial Match (M14 Heritage Match) at the Camp Perry National Matches in Port Clinton, Ohio.

1.2. Participants must be at least 18 years of age to enter the raffle. 1.3. Employees of Fulton Armory, their immediate family members, and any persons living in the same household are not eligible to enter the raffle.

2. Entry

2.1. Each eligible participant will automatically receive one raffle entry upon signing up for, attending, checking in for, and participating in the McKee Memorial Match. 2.2. No purchase is necessary beyond the match registration fee. 2.3. Only one entry per participant will be allowed.

3. Prize

3.1. The prize is one M14 rifle. 3.2. The winner of the raffle will be selected at random from the pool of eligible participants. 3.3. The winner does not need to win the McKee Memorial Match to be eligible to win the rifle.

4. Drawing

4.1. The raffle drawing will take place on the final day of the McKee Memorial Match.

4.2. The winner will be announced at the event. If the winner is not present, they will be notified via the contact information provided during match registration. 4.3. If the winner cannot be contacted within 14 days of the drawing, another winner will be selected at random from the remaining eligible participants.

5. Transfer and Compliance

5.1. The transfer of the M14 rifle is subject to the recipient's state, local, and federal laws.

5.2. Fulton Armory will make reasonable attempts to modify the rifle to meet the recipient's state requirements, if applicable. 5.3. The recipient is responsible for any costs associated with the transfer, including but not limited to background checks, transfer fees, and any modifications required by law. 5.4. The winner must comply with all

federal, state, and local regulations and must provide all necessary documentation to legally transfer the rifle.

6. Changes and Alterations

6.1. Fulton Armory reserves the right to make changes and alterations to the raffle at any time without prior notice. 6.2. Any changes will be communicated to participants as soon as possible.

7. Disqualification

7.1. Fulton Armory reserves the right to disqualify any participant who violates these terms and conditions or engages in any conduct that is deemed unlawful, unfair, or in bad faith.

8. Limitation of Liability

8.1. By participating in the raffle, participants agree to release and hold harmless Fulton Armory, its officers, directors, employees, and agents from any and all liability, loss, or damage arising from or in connection with the raffle or the acceptance, possession, or use/misuse of any prize awarded.

9. Publicity

9.1. By accepting the prize, the winner agrees to allow Fulton Armory to use their name, likeness, and/or biographical information for promotional purposes without additional compensation or notification, except where prohibited by law.

10. Governing Law

10.1. These terms and conditions are governed by and construed in accordance with the laws of the State of Ohio, without regard to its conflict of law principles.
